

**MINUTES of the EXTRAORDINARY MEETING of
The DEVIOCK PARISH COUNCIL

DOWDERRY on THURSDAY 26th NOVEMBER 2009 AT 7.50PM**

Public Participation Period: There being no members of the public wishing to address the Council the Chairman waived the public participation period.

2. TO DECIDE THE PARISH PRECEPT FOR 2010/11:

The Clerk presented figures relating to historical Precept income and expenditure, with reference to the current parish projects, and information on non-Precept income received. Members also had view of the draft Precept proposal that had been submitted for adoption by the Finance and General Purposes Committee.

The Chairman stated that now the new Cornwall Council was in place, it might be possible to progress the parish projects, that had been on hold for some time.

Cllr. Mrs. A. Robinson requested that the Council should allow an amount in the Precept towards the possible future costs of providing a parish burial ground. It was suggested that short-term costs relating to a burial ground could be met from accumulated, unallocated Council funds.

After discussion Cllr. J.P. Candy **proposed** that the **Precept request for 2010/11 be £20,000.00**; Cllr. C. J. Hazel **seconded** this. Cllr. Mrs. M.Y. Byles **proposed an amendment** that the **Precept request for 2010/11 be £23,286.00**; Cllr. Mrs. A. Robinson **seconded** this. **The amendment was adopted**, became the substantive motion and was **agreed** by the Meeting. (See Appendix 1: 2010/11 Precept)
